## 1. Personal data

### 3. Retention of your personal data

### 4. How we share your personal data

In principle, BCFOODS EUROPE B.V., does not share your personal data with third parties. However, we may need to share personal data with third parties to help us provide services and products to you and run our website. These third parties are, for example, not limited to:

- Law enforcement bodies or other supervisors/authorities in order to comply with any legal obligation;
- Service providers where this is needed to provide us with a service and to provide data analytics services.

Sharing of your personal data with the above third parties is only for the purposes stated in this Privacy Statement and only on the basis of principles stated in this statement. Third parties to whom we provide your personal data are responsible for compliance with the privacy legislation. BCFOODS EUROPE B.V. is not responsible nor liable for the processing of your personal data by these third parties.

### 5. Cookies

Cookies are small pieces of text files, containing small amounts of information, which (when visiting our website) are sent to your browser and may be stored on your computer, tablet, mobile phone or other device (hereafter: device). The cookies placed through the website of BCFOODS EUROPE B.V. will not damage your device or the files stored on it. When we talk about 'cookies' we also mean comparable techniques, such as device fingerprinting. These cookies are sometimes necessary to remember your account settings, but also enable us to measure and analyze your behavior on our website. Only analytical cookies are used on our website and no personal data are stored.

### 6. Your rights

You have several rights concerning the processing of your personal data:

- The right of inspection. You can request to have an overview of your personal data processed by or on behalf of us;
- The right to have your personal data rectified, deleted or restricted (as appropriate);
- The right to object to or request the limitation of the processing of your personal data;
- The right to receive your personal data that you have provided to us in a structured, commonly used and machine-readable format;



- You also have the right, in certain circumstances, to require us to stop processing your personal data, but where we have compelling legitimate grounds, we will continue processing your personal data.
